Despite some Australians being victims of terrorist acts at home and overseas, our ignorance about the war in Syria has made it difficult for us to truly empathise with Syrians who have faced unimaginable horrors.

When speaking about the origin of the Syrian crisis, the guest and presenters of *The Minefield* gave no consideration to the perspective of Syrians who would

- (1) not want America, allied with insurgents (who at times <u>work with ISIS</u>), to wage an aggressive war against their country; and
- (2) not want to lose women's freedoms and equalities as well as religious freedoms that are guaranteed by a secular state with its separation of religion and politics.

The August 2013 <u>brutal massacre of around 200 Alawites</u> and the abduction of around the same number, mostly women and children, was a coordinated attack committed by 20 different antigovernment armed groups, ranging from ISIS to the Free Syrian Army. The overwhelming majority of Syrians would condemn both the massacre and <u>the bigoted, murderous hatred</u> that spawned it. But *Minefield* presenters did not present their perspective.

The Minefield program presented a simplistic take on the war in Syria that basically echoed US and Australian foreign policy stands rather than the reasoned thinking one should expect from academics and philosophers.

The stories of two young Syrian men exemplify aspects of the war ignored in *The Minefield*.

In early 2012, a young army conscript on leave was abducted by 'rebels' and, because he was Sunni, he wasn't killed on the spot, but given four choices: 'fight with his captors against the government and kill as many police, soldiers, security agents, and non-Muslims (i.e. non-Sunnis) as possible; take ammunition supplied by them to destroy key infrastructure and wreak havoc; pay a substantial ransom; or be killed on the spot.' ('Syria's 'Arab Spring': failed or hijacked?', Dr Fiona Hill, ABC's The Drum, 14/02/2012)

A popular Palestinian Syrian actor, Mohamed Rafea, also with a Sunni background, spoke out against 'terrorists' in the 2012 documentary 'Manufacturing Dissent: The Truth about Syria'. In an interview with RT about Arab TV satellite channels boycotting popular Syrian soap operas, Rafea spoke about the 'love' Syrians have for each other. In late 2012, he was abducted, tortured and killed by 'rebels'. (BBC report.)

Over a million Iraqi refugees made their home in Syria after March 2003, so Syrians would be aware of the catastrophic consequences of a US-led war. Also, many would have some <a href="knowledge">knowledge</a> of attempts - beginning soon after Syria's independence - by the CIA and MI6 to effect 'regime change' through covert means in their country.

However, instead of giving the above due consideration and remembering the disinformation and distortions that led Australia into the war in Iraq, The Minefield program had a clear bias toward US military action against the Syrian secular state and an inferred bias toward Islamist insurgents with no reference to the chaos and violence they have inflicted across Syria.

  What I was told by intelligence sources at the time was that the evidence against Assad was anything but a slam dunk. It was not even "robust," as Goldberg insists. There were serious doubts among intelligence professionals about many of the "certainties" that Official Washington's neocon-dominated foreign policy establishment had quickly accepted as true about the sarin attack, blaming Assad.

  In the face of that "group think," Clapper surely did not want to go too much against the grain he's far too timid a bureaucrat for that but his analysts were balking at once again being pushed into justifying another hasty war.

Dempsey's initial view after 21 August was that a US strike on Syria – under the assumption that the Assad government was responsible for the sarin attack – would be a military blunder, the former intelligence official said.
